DEPARTMENT OF TRANSPORTATION DRUG TESTING

The Department of Transportation now requires all drivers who provide public transportation to be part of a drug testing program. This program requires testing at the time of licensing, in case of an auto accident and on a random basis. HEALTHSOUTH IMC Health care Centers in conjunction with Corning Nichols Institute and Greystone Services have set up a drug testing program for all private cab drivers. .
