V. <u>NEW BUSINESS:</u>

- A. FY 18-19 1st Quarter Financial Report Steven Tamayo
 Mr. Tamayo presented the 1st Quarter Financial Report. Revenue has decreased by 3%
 over last year. The RFB for the Cab Contract will be cancelled. The lowest bidder was
 not responsive. A new RFB with a modified scope of work will hopefully be released in a
 couple of months.
- B. Substance Abuse Programming Funding Request Jessica Barawed Ms. Barawed outlined the need to enhance substance abuse programming in the detention facilities. According to SANDAG, approximately 70% of the jail population has some type of substance use disorder at time of booking.
- C. Veteran's Module Evaluation Rebecca Cardenas
 Ms. Cardenas outlined the results of SANDAG's evaluation of the Veteran's Module at
 Vista. Overall, the Module is very positive and effective in transitioning veteran's back to

the community. Approximately 90% of participants would recommend it to other veterans.

Patricia Ceballos – Voting is underway with the inmates. If staff has any questions regarding voting, please have them contact the counseling staff at the facilities.

Steven Tamayo – The Farm Stand raised a total of \$845 in revenue and sold 114 items to 40 customers.

Captain Frierson – On November 8th, we are celebrating the 5th anniversary of the Veterans Moving Forward Module.

David King – Coffee and tortillas in ziplock bags have been replaced. The coffee replacement is temporary as Maxwell House will start selling it in regular packaging. Two gift packs still have items with ziplock packaging.

Sergeant Wilson – Sgt. Wilson gave an update on the progress of the CALPIA program at SDCJ and played a video showing the participants utilizing the cleaning machines, as well as in a classroom setting.

Commander Clamser – Video visitation monitors have been installed at EMRF and GBDF and are live. SDCJ goes live on Thursday. The monitors for VDF are being installed at the moment, however, there is a several week delay in running wires in the various housing units. Sgt. Blackwell is working with Revenue and Recovery on SB1210 in collecting restitution from the 1170 and PRCS population.
